The main element of our 2015 project is the Nordic Alcohol Policy report. By now we have created an online format, a webpage, that will host the report. The page and most of the content can be seen here: <http://nordan.org/report>

Together with our board members and member organisations we have done a questionnaire to gather the main body of information mapping the alcohol policy situation in our member countries. We have done a number of videos with different members focusing on various aspects in alcohol policy. The report is finalised in coming months and is launched at the Helsinki conference on October 24.

In March we organized a passive drinking conference in Tallinnas, Estonia. Passive drinking is one of the main arguments and themes of the Advocacy North project. Conference included following speakers: Dr Ann Hope from Ireland, Dr Inger Synnøve Moan from Norway and Dr Christoffer Tigerstedt from Finland. In June we organized in Stockholm a open roundtable on Nordic Alcohol Policy Report and on the alcohol policy situation in Nordic-Baltic countries.
